# Syrian Court Sentences Bashar al-Assad to Death in Absentia for War Crimes

*The Fourth Criminal Court in Damascus sentenced former Syrian President **Bashar al-Assad**, his brother **Maher al-Assad**, and seven others, nine defendants in total, to death on **August 11, 2026**, for crimes against humanity and war crimes committed during Syria's 14-year civil war, marking the first conviction handed down since Assad's regime fell.*

## THE VERDICT AND ITS DEFENDANTS

Bashar and Maher al-Assad were among eight of the nine defendants tried and sentenced **in absentia**; both brothers have fled to Russia, which granted them asylum after Damascus fell. Their cousin **Atef Najib**, a former political security chief of Daraa province, was the only defendant tried in person, appearing in court in a prisoner's uniform. All nine, including former Defence Minister Fahd Jassem al-Frej and five other former security and intelligence officials, were convicted on charges tied to crimes against humanity and war crimes arising from Syria's civil war, a conflict estimated to have killed more than 500,000 people over its course. Maher al-Assad had commanded the Syrian Army's elite 4th Armoured Division, widely implicated in crackdowns during the conflict.

## FROM REGIME COLLAPSE TO FIRST CONVICTION

The Assad family's rule over Syria ended on **December 8, 2024**, when the regime collapsed after a rapid rebel offensive, closing out 54 years of Assad-family control (Bashar's own 24-year presidency, preceded by his father Hafez al-Assad's rule). Syria's transitional government, now led by President **Ahmad al-Shara**, has since begun prosecuting former regime figures for civil-war-era atrocities; the August 11, 2026 verdict is the first such conviction to be handed down, an early test of the new government's transitional-justice machinery.

## TRANSITIONAL JUSTICE CHALLENGES

The verdict illustrates two structural tensions common to post-regime transitional justice: first, the practical difficulty of enforcing sentences against defendants tried **in absentia** when the host country (Russia, in Assad's case) is unlikely to extradite them, especially after having granted asylum; and second, the broader

policy choice between retributive justice (trials and sentencing) and reconciliation-oriented mechanisms (truth commissions, amnesties) in societies emerging from prolonged civil conflict. Syria's new government appears to have opted for the former in this case, a decision with implications for how displaced Syrians, minority communities, and international observers judge the transition's legitimacy.
